- 3 Bidding will be conducted through **Emergency Request for Quotations (RFQ)** procedures specified in accordance with the Public Procurement and Disposal of Assets Act 2017 of the Government of the Republic of Malawi.

- 5. Each Bidder will be required to supply the following documents or confirm their acceptance to agree to registration of themselves and the product to be supplied at the time they submit their Bid:
 - (a). All medical Supplies must have a remaining shelf-life of at least 80% at the time of receipt by the CMST Receiving Store, New Pharmaceutical Warehouse, Lilongwe Malawi.

- (b). A sample of each medical supply, as specified in the RFQ, must be provided at the same time as the Quotation is submitted. Any quotation submitted without the samples being supplied will be rejected as noncompliant.
- 6. Quotations must be deposited in the Tender Box at address 9(c) below on or before 17th April 2020 at 14.00 hours local time. Electronic bidding will not be permitted and Late Bids will be rejected. Quotations will be opened in the presence of the bidders' representatives who choose to attend at the address 9(d) below on before 17th April, 2020 at 14.00 hours local time.
