## INVITATION TO BID

**International Competitive Bidding Date of Issue: 6<sup>th</sup> June 2020**

**Subject of Procurement: Re-Alignment of Current Racks, Supply, Delivery, Installation of Additional Racks, Reach Trucks and Impeller Fans in Warehouses**

1. Central Medical Stores Trust (CMST) has funds under Global Fund grant through Government of Malawi Ministry of Health (MoH) and intends to apply part of the funds towards payments for Re-Alignment of Current Racks, Supply, Delivery, Installation of Additional Racks, Reach Trucks and Impeller Fans.
2. The Chairperson, Internal Procurement and Disposal of Assets Committee, CMST now invites sealed bids from eligible and qualified bidders for the stated procurement in respect of the Lots provided in table below;

1(a)	Re-alignment of current racking to create a 1.8m aisle environment at CMST National Pharmaceutical Warehouse in Lilongwe
1(b)	Supply, delivery and installation of adjustable racking to accommodate Additional 960 pallets with 1.8meter aisle at CMST National Pharmaceutical
1(c)	Supply, delivery and installation of adjustable racking to accommodate 1,260 pallets with 1.8meter aisle at CMST-Blantyre Regional Medical Stores.
2	Supply, delivery of Reach Trucks and provision of training to operators
3(a)	Supply and Delivery of Impeller fans at CMST-Blantyre Regional Medical Stores
3(b)	Installation of Impeller fans at CMST-Blantyre Regional Medical Stores

The Bidder must quote for the total quantities of the items offered and bids will be evaluated lot wise. Qualification requirements include a minimum of two (2) years in the overall experience of the Supplier in the supply of similar goods.

- 3 Bidding will be conducted through **International Competitive Bidding (ICB)** procedures specified in accordance with the Public Procurement Act 2017 of the Government of the Republic of Malawi.
4. Interested bidders may obtain further information and inspect the Bidding Documents from the **Procurement Manager** address given at 8(a) below from 08.00 to 12.00 and 14.00 to 16.00 hours local time (Monday to Friday, except national public holidays).
5. A Bidding Document in English Language may be purchased by interested bidders from the address at 8(a) below upon payment of a non-refundable fee of MWK 10,000.00 or equivalent of USD14 to the address at 8(b) below. The method of payment will be Malawi Kwacha, either in cash or a bank certified cheque or any other convertible currency.

6. Bids must be accompanied by a Bid Security of **1% of the Total Bid sum offered** The Bid Security must be in form of a Bank Certified Cheque or Bank Guarantee issued by a reputable bank agreeable to the Purchaser.
7. Bids must be deposited in the Tender Box at address 9(c) below on or before **29<sup>th</sup> June 2020 at 14.00 hours local time**. Electronic bidding *will not* be permitted and Late Bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address 9(d) below on **29<sup>th</sup> June 2020 at 14.00 hours local time**.
