- 6. Bids must be accompanied by a Bid Security of **USD2**, **800.00 (MK2**, **000,000.00)**. The Bid Security must be in form of a Bank Certified Cheque or Bank Guarantee issued by a reputable bank agreeable to the Purchaser.
