1. Central Medical Stores Trust (CMST), with funding from Malawi Government has resources for the procurement of Medical Supplies.
2. The Chairperson, Internal Procurement and Disposal of Assets Committee, now invites sealed bids from eligible and qualified bidders for the urgent supply and delivery of Medical Supplies:

3. The Bidders must quote for the total quantities of the items offered and bids will be evaluated item by item. Qualification requirements include a minimum of two (2) years in the overall experience of the Supplier in the supply of similar goods.
4. Bidding will be conducted through **National Competitive Bidding (NCB)** procedures specified in accordance with the Public Procurement Act 2017, Public Procurement Regulations (2020) of the Government of the Republic of Malawi.
5. Interested bidders may obtain further information and inspect the Bidding Documents from the **Procurement Manager** at address given at **10(a)** below from 08H00 to 12H00 and 14H00 to 16H00 hours local time (Monday to Friday, except national public holidays).

6. A Bidding Document in English Language may be purchased by interested bidders from the address at **10(a)** free of charge.
7. Each Bidder will be required to supply the following documents or confirm their acceptance to agree to registration of themselves and the product to be supplied at the time they submit their Bid:
  - (a).The medical supplies must have a remaining shelf-life of at least 80% at the time of receipt by the CMST Receiving Store, National Pharmaceutical Warehouse, and Lilongwe, Malawi.
8. Bids must be accompanied by a **Bid Securing declaration in the format specified in the solicitation documentation.**
9. Bids must be deposited in the Tender Box at address **10(b)** below on or before **12<sup>th</sup> May 2021 at 14H00 hours local time**. Electronic bidding *will not* be permitted and Late Bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address **10(c)** below on **12<sup>th</sup> May 2021 at 14H00 hours local time**.
