INVITATION TO BID

National Competitive Bidding Date of Issue: 5th August 2020

Subject of Procurement: Supply and delivery of Medicines and Medical Supplies

- 1. Central Medical Stores Trust (CMST) has budgeted financial resources and intends to apply part of the funds towards payments for procurement of **Medicines and Medical Supplies through Indefinite Quantity** Agreements.
- 2. The Chairperson, Internal Procurement Committee, CMST now invites sealed bids from eligible and qualified bidders for the supply and delivery of various Medicines and Medical Supplies:

The Bidder must quote for the total quantities of the items offered and bids will be evaluated item by item. Qualification requirements include a minimum of two (2) years in the overall experience of the Supplier in the supply of similar goods.

- 3 Bidding will be conducted through **National Competitive Bidding (NCB)** procedures specified in accordance with the Public Procurement Act 2017 of the Government of the Republic of Malawi.
- 4. Interested bidders may obtain further information and inspect the Bidding Documents from the **Procurement Manager** address given at 9(a) below from 08.00 to 12-00 and 14.00 to 16.00 hours local time (Monday to Friday, except national public holidays).
- 5. A Bidding Document in English Language may be purchased by interested bidders from the address at 9(a) below upon payment of a non-refundable fee of **MK 5,000.00** to the address at 9(b) below. The method of payment will be Malawi Kwacha, either in cash or a bank certified cheque or any convertible currency.

- 6. Each Bidder will be required to supply the following documents or confirm their acceptance to agree to registration of themselves and the product to be supplied at the time they submit their Bid:
 - (a).The Supplier of all medicines must have a current valid c-GMP certificate, certificate of analysis (CA), COPP certificate and copies of each must be supplied with the bid. In addition, all medicines must have a remaining shelf-life of at least 80% at the time of receipt by the CMST Receiving Store, National Pharmaceutical Warehouse, Lilongwe, Malawi.
 - (b).A sample of each medicine/Medical Supplies, as specified in the bidding document (except for vaccines and controlled medicines), must be provided at the same time as the Bid is submitted. Any bid submitted without the samples being supplied will be rejected as non-compliant.
 - (c).The medicines must be registered in Malawi with the Pharmacy and Medicines Regulatory Authority (PMRA), by the time the product is ready for shipment. Copies of the registration document or a letter confirming that they will be registered by the time of supply must be provided with the bid submitted by the Bidder.
- 7. Bids must be accompanied by a Bid Security of 1% of the Total Bid Value of the item (s) contested/Bid Securing declaration. The Bid Security must be in form of a Bank Certified Cheque or Bank Guarantee issued by a reputable bank agreeable to the Purchaser.
- 8. Bids must be deposited in the Tender Box at address 9(c) below on or before 4th September 2020 at 14.00 hours local time. Electronic bidding will not be permitted and Late Bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address 9(d) below on 4th September 2020 at 14.00 hours local time.
